<b>What is the overall <u>deductible</u>?</b>	Calendar year aggregate deductible. In-network: \$2,000 Individual / \$4,000 Family. Out-of-network: \$2,000 Individual / \$4,000 Family.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the policy, the overall family <u>deductible</u> must be met before the <u>plan</u> begins to pay.
<b>Are there services covered before you meet your <u>deductible</u>?</b>	Yes. Does not apply to services listed below as "No charge"	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount.
